- a. Utility/Housekeeper 8
- b. Company Driver 2
- c. Handyman 2
- d. Gardener 1

## 2. Areas to be covered

- a. **Housekeeping** materials and equipment needed to maintain the cleanliness and orderliness of the North and Main Clubhouse including two (2) meters of its surroundings except the kitchen, Motorpool Office and Fish Pond.
- Qualified and experienced Handyman to undertake upkeep repair and maintenance tasks at the interior or exterior of the Clubhouses and other special project of the company.
- c. Qualified and experienced Company Driver. Keeping the vehicle clean, in perfect shape, maintained and running well is a big responsibility for the person in this position.
- d. Qualified and experienced **Gardener** to maintain the beauty of plants indoor and outdoor grounds, will perform a general range of maintenance including designing, producing, renewing, and preserving outside spaces.
- 3. The contract shall be for a period of two (2) years starting from the issuance of the Notice to Proceed.
- 4. At least five (5) years experience in providing Manpower Agency Services

- 5. All bids must be accompanied by a <u>Cash Bond of P 50,000.00</u>, refundable to non-winning bidders within thirty (30) days from date of opening of bids.

  - k. Certificate under Oath that the bidder has complied with all pertinent Labor Laws.
  - I. Sworn affidavit of the bidder that he/she or any officer of the corporation is not related to the President of Valley Golf & Country Club, Inc. by consanguinity or affinity up to the third civil degree.
- 11. Questions or clarifications regarding the Bidding shall be made in writing and be submitted in the Office of the General Manager on or before March 20, 2019.
- 12. Submission of <u>FINAL SEALED BIDS</u> will be on or before March 23, 2019, 1:00 pm in the Office of the General Manager.
