PRESIDENT'S MESSAGE

Giving exemplary services to our members, their families and guests has always been the goal of the Board of Directors. After ten (10) months since I sat as the President and Chairman of the board, I am pleased to highlight significant accomplishments of our club:

- 1. We have decreased our expenses by implementing the maintenance program contract for our golf courses with a company that has a good track record for the next three years.
- 2. Through our voluntary retirement program, we decreased the number of personnel, from 169 to 93.
- 3. You may also notice significant improvement in the condition of our Golf Courses.
- 4. We also improved the drainage at hole no. 5 of the South Course.
- 5. We constructed Bunker and Pitching shot practice areas.
- 6. We improved the façade of the bag drop area and bulletin board area.
- 7. We improved the swimming pool area.
- 8. We repainted our clubhouse roof and tee houses.
- 9. In addition to our yellow golf carts which run on gasoline, we also purchased ten (10) units of brand new electric
- 10. We purchased a top of the line backhoe, of which we are now desilting of lakes and ponds in preparation for the upcoming rainy season.
- 11. We installed lights around our clubhouse. We also installed lights at Hole 18 of the South course, through the help of our members who sponsored the project. We will continue to put up lights at Holes 8, 9 and 17 so that you can now start playing at 3pm and finish the 18 holes.
- 12. We improved the uniform of our caddies and umbrella girls to be more presentable.
- We even have complimentary coffee and juice for members and guests.
- 14. Last but not the least, the value of Valley Golf share increased from P150k -180k range to P200-250 Thousand

All of these were made possible through the help and cooperation of the Board of Directors, members, MJ Carr Golf Management, Inc., the employees and the Valley Golf family.

Also, please allow me to take this opportunity to inform you of the developments and projects we are going to accomplish in the coming months:

- 1. Further improvement of bag drop and caddy area.
- 2. Improvement of our driving range
- 3. Improvement of F&B (restaurant) services.
- 4. Improvement of the present handicapping system & related issues.
- 5. Improvement of other club facilities & new facilities like tennis, basketball, badminton court.
- 6. Pro active service of club employees.
- 7. Cost reduction & clean & green programs.
- 8. Of course the most important, the continuing improvement of the fairways and greens.

We also have on-going green fee promos such as the play-all-you-can at the North Course and Sunday afternoon promo.

I would also like to congratulate our 16th Don Celso Tuason and Founders'Cup Chairman for this year, Mr. Gerry Marcelo, and the Committee members for a job well done. We are proud of you for enabling a smooth tournament from day one (1) to its conclusion.


