Let's bid goodbye with divine thanks for the year 2015 and welcome 2016 with unlimited dreams and enthusiasm.


Your board wishes once again to re-emphasize our commitment for good corporate governance and financial discipline and transparency in the stewardship of the operations of our club.

We have just completed the first year of engagement with MJ Carr Golf Management, Inc. for the three-year rehabilitation (than maintenance works) of the greens and fairways. You may note that our greens and fairways has been contaminated with viruses and undesirable grass, hence taking time for full recovery of our golf course. Additionally, we are doing the rehabilitation of the bunkers, too. MJ Carr gave us the assurance that we will see our golf course in pristine condition at the end of the second year of the rehabilitation.

Given the significant investment we made in the rehabilitation of our golf course, the Board is now focusing on the alternative sources of revenues and managing and rationalizing the expenses. Ad hoc committees were formed – on the Improvement of the North Clubhouse to focus on raising revenues and on Reciprocity and Marketing to market Valley Golf amenities to hotel tourists and to forge reciprocal arrangements with local and foreign golf clubs.

In addition to our existing six reciprocal arrangements, we just signed up with Sherwood Golf and Country Club.
