



Revised III Reopening Guidelines

With the declaration of GCQ (General Community Quarantine) in Region IV-A Valley Golf will reopen under the guidelines below. Keep in mind this is a fluid situation, and guidelines may be revised, eased, or tightened as the Board and Management see fit.

PLEASE NOTE : Seniors 60 above and persons under 21 years of age may play provided they sign a waiver of liability, and travel restrictions of point to point trip only (house/office to golf course and vice versa). Thus we are pleased to announce that on 27 May 2020 Valley Golf Club will reopen to members under the detailed Guidelines and Restrictions already published.:

General Recommendations:

- Only Club Members, (Members for all guideline purposes herein includes spouse and children dependents) may use the facilities during GCQ
- NO MASK NO ENTRY
- Thermal screening will be done for EVERYONE who will enter at Bridge Gate.
- Every member will sign a liability waiver before using the club and facilities.
- **If a member, staff, or caddy (that has been to Valley since the lifting of ECQ) has tested positive or is PUI** (not necessarily from exposure at Valley Golf), the following protocol will be implemented:
 - Temporary closure again for complete re-sterilization.
 - Self-quarantine any member or staff that came in contact with the positive person since that person was at Valley
 - Re-opening date to be announced.
- Only the main clubhouse entrance and parking entrance will be used for members and employees with 100% passage through thermal screening and a disinfecting foot bath.
- Social distancing guidelines and markings will be put in place at reception counter for check in.
- Drivers/ Bodyguards are Not Allowed to enter the club house.
- The Club will follow all government and DOH recommendations and will brief all staff and caddies on heightened hygiene, sanitation, and (for those in F&B) food handling standards to minimize the risk of contamination.
- The Club will require all employees and caddies to wear the appropriate face mask and undergo frequent hand washing **as advised by the Club medical professionals.**
- Absolutely NO WALK Ins. Advanced Tee time reservation is mandatory.
- During GCQ tee off times will be required and limited to every 12 minutes and to avoid congestion ONLY the first tee will be used to start. A detailed protocol on making tee times will be communicated in a separate document.
- The Club will place clear and appropriate signage **as approved by medical professionals** at strategic locations throughout the premises, to clarify social distancing guidelines in place.
- Limited menus will be available with only take away food service. Tables will be combined, but only 3 persons will be allowed at an 8-seater table to await orders.
- Tee houses will have packaged items, but no tables and chairs for seating.
- No consumption of alcoholic beverages.

- Anix, and Jays will be open during GCQ, only to Club Members, however hours may be limited as necessary.
- There will be no indoor activities.
- When the driving range is opened, it must submit a detailed plan on how it will ensure maximum social distancing and sanitizing of all surfaces and golf balls between each player user. And this must include that NO two-practicing individuals may be on adjacent hitting areas. As with other facilities, during GCQ, **open only to Club Members.** Driving Range F&B guidelines will be same as main clubhouse mentioned above.
- All guidelines will be shared through all in-club communications systems and will be posted on bulletin boards and other signage.

On the Course:

- To reduce overcrowding, both North and South Courses will be open daily until further notice.
- Everyone must wear appropriate face masks at all times **as approved by medical professionals.**
- Increase time intervals between flights to spread out players. Maximum 3 players per flight including weekends and holidays. As per attached tee off time guidelines.
- The Club will implement with strict enforcement of hygiene practices and use of protective equipment, one player to one caddie. During this time to eliminate unnecessary crowding, CAs (formerly known as Umbrella Girls) will not be allowed.
- Only one person, the member, may ride in or drive the cart. Caddies MUST walk.
- Caddie is still mandatory, however, a player may opt to not use a caddie but pay a specified minimum caddie fee (that will go to a general caddie assistance fund)
- Pins must not be touched. The cup will be raised by one inch (or in some other way protected to prevent balls from going in the hole), so that any ball that hits the raised cup shall be deemed holed. A “gimme” circle will be employed to ensure social distancing on the greens. No hole in one awards will be issued during this time.
- A photo of the scorecard shall be accepted via your designated messaging app and number.
- Players must dispose of any trash they may have after the round at a designated area.
- Abide by gathering limits set by the DOH.

Hygiene and Sanitation:

- Sanitizing will continue every 4 hours.
- Increase alcohol or hand sanitizer locations throughout the club and course where possible, most especially at entry points.
- Ensure sanitation of all golf carts. Sanitize all other items and surfaces that players and staff will probably come into contact with.
- Members may access their personal locker however, shower facilities will be off limits, and no Club bath or fairway towels will be issued.
