SUBJECT: INVITATION TO BID FOR SECURITYSERVICES

Interested parties are hereby invited to submit a **Letter of Intent** to provide **SECURITY SERVICES** for Valley Golf & Country Club Inc.

- 1. To be able to participate in the bidding, all interested parties shall have atleast five (5) years in providing security services
- 2. Submission of Letter of Intent on/before February 16, 2021, 1:00 pm via email at <a href="mailto:cristinaodon.vgcci@gmail.com">cristinaodon.vgcci@gmail.com</a> or personal at the Internal Audit's Office.
- 3. Interested bidders are required to submit the following **PRE-QUALIFICATION DOCUMENTS** in the Office of the Internal Auditor on February 16, 2021, 1:00 pm.
  - a) Company Profile
  - b) Security License from PNP-SAGSD
  - c) Department of Trade and Industry (DTI) business name registration or SEC Registration Certificate, whichever may be appropriate.
  - d) SEC Certificate of Registration, Articles of Incorporation, By-laws, and latest General Information Sheet (GIS) in case of corporations or partnership with paid-up capital of atleast P5 Million
  - e) DOLE Certificate of Registration pursuant to Department Order 174 (Series of 2017)
  - f) Valid Mayor's Permit/Business permit for current year.
  - g) BIR Registration Certification, which contains the Taxpayer's Identification Number.
  - h) 2015 to 2019 Income Tax Returns or Tax Clearance
  - i) Audited Financial Statements stamped "received" by the BIR for the immediately preceding calendar/fiscal year and for the last three (3) years.
  - j) Certification under Oath that each of the documents submitted in satisfaction of the eligibility requirements is an authentic and original copy, or a true and faithful reproduction of the original, complete and that all statements and information provided therein are true and correct.
  - k) Certificate under Oath that the bidder has complied with all pertinent Labor Laws.
  - Affidavit of the bidder that he/she or any officer of the corporation is not related to the Board of Directors of Valley Golf & Country Club, Inc. by consanguinity or affinity up to the third civil degree.
  - m) List of Major Clients (active/inactive), including name contact person and address of Clients, for the past five (5) years
  - n) List of Insurances and coverage amount, if any
  - o) SSS, PAGIBIG, Philhealth Contribution payment for the last three (3) months
  - p) Frequency of Neuro psycho test / Anger /stress management seminar or equivalent being conducted to guards
  - q) Minimum Requirement for Guard Selection
  - r) Security Plan, maximum of three (3) pages only

- 4. Interested bidders are required to attend the **PRE-BID CONFERENCE** on <u>February 23, 2021</u> via zoom. Notice of pre-bid conference will be sent out on February 22, 2021 5:00 pm.
- 5. Submission of **FINAL SEALED BIDS** will be on or before March 4, 2021 1:00 pm in the Internal Audit's Office using the format specified by the Bids and Awards Committee.
- 6. All bids must be accompanied by a <u>Cash Bond of two hundred forty thousands Pesos</u> (P240,000.00) either in Cash or Manager's Check, refundable to non-winning bidders within sixty (60) days from date of opening of bids.
- 7. **OPENING OF SEALED BIDS** will be on March 4, 2021, 1:30 pm.
- 8. To qualify in the bidding, Agency fee shall not be less than 20% of the Bid Price.
- 9. Number of days to be used in the bidding shall be 393.50 days
- 10. Valley Golf reserves the right to accept or reject any bid, to cancel/or annul the bidding process, and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders.
- 11. Valley Golf reserves the right to reduce the number of guards deployed and/or amend the terms and conditions at any time during the duration of the bidding process or of the contract without incurring any liability to the affected bidder or bidders.
- 12. The Board of Directors, Officers, Members of Committees and Employees of Valley Golf are prohibited to participate in the Bidding.
